#### 1. Thousands of cases of currency smuggling have been detected in Russia

Currency smuggling worth 922.4 million rubles was revealed in Russia. In the first half of the year, customs identified 5,449 cases. The most common destinations for currency were Turkey, the UAE and Azerbaijan.

In drafting it, lawmakers left a loophole by establishing a system of exceptions for nuclear power plant operators that do not have "viable alternative fuel sources, or for any imports that are considered to be in the national interest."
